India, Indonesia, Turkey, Bangladesh, Sri Lanka, China, Iran, Afghanistan, Iraq, American Samoa, Somalia, Botswana, Lebanon, Syria, United States Virgin Islands, Cuba, Sudan, Haiti, Yemen and banned countries.

5. To be eligible for this promotion, clients must opt-in to be part of it by confirming their decision via the client portal.
6. Eligible clients will receive the following credit bonus:

The examples in the table below show how the credit bonus is calculated based on your first-time deposit (FTD) amount.

Your FTD	Your Credit Bonus
\$500	$\$500 \times 20\% = \100
\$1,000	$\$1000 \times 20\% = \200
\$5,000	$\$2500 \times 20\% + \$2500 \times 10\% = \$750$

- The total Credit Bonus is capped at 10,000 USD (or currency equivalent) per eligible client at any time during this promotion.
- Internal transfers, balance or cash adjustments, introducer/affiliate rebates, or commissions are not considered new deposits and are not eligible for this promotion.
